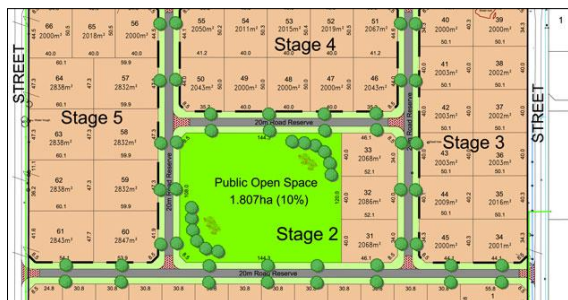


Planners Guide to Subdivision
