

## **Test and Tag Compliance and Requirements for the Construction Industry**

Conduct in-service safety testing of electrical cord assemblies and cord connected equipment UEENEEP026A Attach cord & plugs to electrical equipment for connect to a single phase 250 volt supply UEENEEP024A (The Registered Training Organisation Nara Training and Assessing 4518 will be the RTO issuing this qualification)

Amendments were made to the OSH Regulations to allow a competent person to test and tag portable electrical equipment for use on a construction and/or demolition site. As required by the Occupational Safety and Health Act and Regulations the course provides participants with the knowledge and skills required to test and tag portable electrical equipment on demolition, construction and mine sites.

The attaching flexible cord and plugs to electrical equipment for connection to supplies up to 230V a.c. encompasses working safely, identifying plug configurations, selecting and using testing and measuring devices, terminating and connecting cords/plugs and conductors, safety testing and reporting.

**Pre-requisites:** You must complete and return the assessment for UEENEEE101A Apply occupational health and safety regulations, codes and practices in the workplace at least 2 days prior to the commencement of this course (Assessment paperwork will be available once completed registration form is received). Also, you are required to bring a piece of electrical equipment with you to this course.







On successful completion you will receive your Statement of Attainments for UEENEEP026A Conduct in-service safety testing of electrical cord assemblies and cord connected equipment and UEENEEE101A Apply Occupational Health and Safety regulations, codes and practices in the workplace. UEENEEP024A Attach cord & plugs to electrical equipment for connect to a single phase 250 volt supply.
