# Restricted Asbestos Removal Licence

## RAL001

**A licence is required in Western Australia for removal of materials that contain asbestos.**

A Restricted Asbestos Removal Licence will allow people to remove amounts exceeding 10 square metres of bonded (non-friable) asbestos. The licence will be valid for three years and there is no pre-requisite for this course.

### MODULE 1: LEGISLATIVE FRAMEWORK

1. Describe the legislative requirements of the Occupational Safety and Health Act 1984, supporting Regulations and associated Codes and Standards.
2. Identify types of asbestos, including friable and non friable asbestos and its uses.
3. Describe the health effects relating to asbestos exposure.

### MODULE 2: RISK MANAGEMENT

1. Identify hazards in the work area.
2. Conduct a risk assessment.
3. Identify the controls required.
4. Identify and select PPE & clothing
5. Prepare a Safe Work Method Statement.

### MODULE 3: REMOVAL & DISPOSAL OF NON FRIABLE (BONDED) ASBESTOS

1. Plan the removal of asbestos.
2. Outline procedures for the removal of asbestos.
3. Outline procedures for clean up and decontamination of worksite, tools and workers.
4. Identify the methods of transporting and disposing of asbestos containing materials safely in accordance with the regulatory requirements.

*On successful completion of this course (80% passmark required on written examination), participants can apply to WorkSafe for a Restricted Asbestos Work Licence.*
