

Restricted Asbestos Removal Licence RAL001

A licence is required in Western Australia for removal of materials that contain asbestos. Only a licence holder or an employee of a licence holder may carry out this type of work.



A Restricted Asbestos Removal Licence will allow people to remove amounts exceeding 10 square metres of bonded (non-friable) asbestos. The licence will be valid for three years and there is no pre-requisite for this course.

3 Modules covering the following: -

- Legislative Framework
- Risk Management
- Removal and disposal of non-friable (bonded) asbestos

Asbestos is a hazardous material and its removal needs to be carried out by trained and experienced operators who are licensed. Those completing this course will be able to properly supervise, manage and carry out asbestos work involving non-friable (bonded) asbestos-containing material.

- > Wear appropriate protective clothing & footwear, no thongs/singlets.

On successful completion of this course (80% passmark required on written examination), participants can apply to WorkSafe for a Restricted Asbestos Work Licence.
