(The Registered Training Organisation, WBHO Civil Pty Ltd 52336 will be the RTO issuing Statement of Attainment for this unit of competency).

This unit involves the skills and knowledge required to operate a forklift, including checking forklift condition, driving the forklift to fulfil operational requirements, monitoring site conditions, and monitoring and maintaining forklift performance.

Assessment of this unit will be undertaken within a licensing examination conducted by an accredited assessor under the authority of WorkSafe WA.

Pre-requisite: Participant must:

- be at least 18 years of age and
- Can use the English language at a level that enables the safe performance of high risk as specified in the competency standards.
- Supply two forms of identification (One form of I.D. must be government issued photo I.D. e.g. a Passport or an Australian driver's license).
- Must wear appropriate attire and fully enclose shoes
- Must have a Unique Student Identifier (USI) <u>www.usi.gov.au</u>

Upon successful completion of the assessment requirements you will be issued with a Statement of Attainment for TLILIC2001A Licence to Operate A Forklift Truck)
