## Restricted Asbestos Removal Licence RAL001

A licence is required in Western Australia for removal of materials that contain asbestos.



A Restricted Asbestos Removal Licence will allow people to remove amounts exceeding 10 square metres of bonded (non-friable) asbestos. The licence will be valid for three years and there is no pre-requisite for this course.

3 Modules covering the following: -

- Legislative Framework
- Risk Management
- Removal and disposal of non-friable (bonded) asbestos

On successful completion of this course (80% passmark required on written examination), participants can apply to WorkSafe for a Restricted Asbestos Work Licence.
