Contractors know this is a never-ending question in the building industry with no easy answers.

What adds to the confusion are various state and federal laws such as superannuation, income tax, payroll tax, long service leave and workers' compensation which all have an influence on the issue but provide differing outcomes.

Builders and sub-contractors now also have to be aware of the new obligations imposed under the 2016 Federal Building Code against alleged sham sub-contracting. That is, builders engaged on 2016 Federal Code projects need to demonstrate they are taking measures against this practice.

Contractors need guidance in how to navigate their way through what is a complex grey area, and that is where Master Builders is able to assist, by providing cut through user friendly information about how to minimise the potential risk of getting the answer wrong. Incorrectly classifying employees as sub-contractors can have serious implications for employers such as paying wages and other award entitlements, paying superannuation contributions and more, as well as having financial penalties applied if convicted by a court.
