THE QUESTION

I understand that six-star is the minimum standard for houses, but the scale goes up to 10 stars. Sustainability is definitely enhanced or reduced by how the homeowner uses the home, but I would like to know how the builder can be more sustainable with the construction. Do builders consider this?

THE ANSWER

When we talk about a 'sustainable building' we mainly focus on the energy the building is likely to consume and how the building can be designed to be more sustainable, but the design and construction of the building impacts the environment well before we occupy it.

Following passive-solar design principles like good orientation, including thermal mass and insulation, providing cross-ventilation and reducing air leakage help in lowering greenhouse gas emissions by reducing the amount of heating and cooling required. As occupiers, we can further improve the efficiency by landscaping to shade windows in summer and allow warm sun through in winter, opening and closing blinds and curtains and using efficient lighting and appliances - all reduce our operational energy and save on operational costs.

The environmental impact of a building is more than just its running costs. The energy used to produce the materials from natural resources. the transportation costs from where the materials are manufactured to the site and then the energy used to construct the building as it stands - this is the building's embodied energy.

Each building is unique. Each home or commercial building will have its own set of components depending on the selections of the client, the location of the building and the contractor's work methods to put the building together.

The lifecycle of appliances, computers and motor vehicles, for example, can be quite accurately calculated and any variables easily accounted for, as they are made on production

Although the materials and components may be sourced from a range of raw materials and from other countries, these manufactured products are much less complicated when compared to the construction of a building.

Unlike vehicles and computers. buildings have a much longer life span. In the last five years, there has been a large shift in the way construction and demolition sites are managed for waste.

More and more materials are reused and recycled.

As landfill costs continue to rise, we are becoming more efficient with ordering materials, and selective of what remains waste that cannot be reused or recycled.

There are many passionate architects, designers and builders that exceed the minimum standard for energy efficiency and consider the use of recycled materials or materials with lower embodied energy.
