#### **MAJOR APPRENTICE AWARD CATEGORIES**

#### **APPRENTICE OF THE YEAR** (non-entered)

Recognises the overall best Building and Construction Industry apprentices across all categories who have demonstrated commitment to their training. Applicants will be assessed on their overall achievement in studies and on-the-job training via written submission and subsequent interview.

Most Outstanding First / Second / Third / Fourth Year Apprentice Award winners and the Regional Apprentice of the Year compete to win the overall Master Builders Apprentice of the Year Award.

#### MOST OUTSTANDING REGIONAL APPRENTICE (non-entered)

Recognises Building and Construction Industry apprentices who have demonstrated commitment to their training. Applicants will be assessed on their overall achievement in studies and on-the-job training.

The overall winner from the regions (Goldfields Esperance, Mid West, Great Southern, South West and Kimberley Pilbara) will go into the running for the 'Apprentice of the Year' Award, to be presented in Perth.

#### MOST OUTSTANDING FEMALE APPRENTICE (non-entered)

Recognises female Building and Construction Industry apprentices who have demonstrated commitment to their training. Applicants will be assessed on their overall achievement in studies and on-the-job training via written submission and subsequent interview.

Female Apprentices must first nominate for an Apprentice Award and win their nominated Trade Category to be eligible to be a finalist for this Award.

#### MOST OUTSTANDING ABORIGINAL/TORRES STRAIT ISLANDER APPRENTICE (non-entered)

Recognises Aboriginal and Torres Strait Islander Building and Construction Industry apprentices who have demonstrated commitment to their training. Applicants will be assessed on their overall achievement in studies and on-the-job training via written submission and subsequent interview.

Aboriginal and Torres Strait Islander Apprentices must first nominate for an Apprentice Award and win their nominated Trade Category to be eligible to be a finalist for this Award.
